

AN ORDINANCE PROHIBITING ANY PERSON UNDER THE INFLUENCE OF INTOXICATING LIQUOR FROM ENTERING OR GOING UPON ANY PUBLIC SCHOOL GROUND, PUBLIC SCHOOL BUILDING, PUBLIC SCHOOL ATHLETIC FIELD OR ARENA, AND ANY PUBLIC PARK OR ARENA IN THE TOWN OF BEASLEY; AND PROHIBITING THE POSSESSION OF ANY BOTTLE, OR OTHER CONTAINER, CONTAINING ANY INTOXICATING LIQUOR IN OR UPON ANY PUBLIC SCHOOL GROUND, PUBLIC SCHOOL BUILDING, PUBLIC SCHOOL ATHLETIC FIELD OR ARENA, OR ANY PUBLIC PARK OR ARENA IN THE TOWN OF BEASLEY; PROVIDING FOR A PENALTY THEREFOR; AND ESTABLISHING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF BEASLEY, FORT BEND COUNTY, TEXAS:

SECTION 1. Any person who shall enter or go upon any public school ground, public school building, public school athletic field or arena, or any public park or arena in the Town of Beasley while under the influence of intoxicating liquor shall be deemed guilty of a misdemeanor.

SECTION 2. Any person who shall enter or go upon any public school ground, public school building, public school athletic field or arena, or any public park or arena in the Town of Beasley while in possession of any bottle, or other container, containing any intoxicating liquor shall be deemed guilty of a misdemeanor.

SECTION 3. Any person convicted of an offense as set out in Section 1 or Section 2 of this Ordinance, shall be fined not less than \$10.00 nor more than \$200.00.

SECTION 4. That this Ordinance shall become effective after its passage and publication according to law.

NOTICE

On the 19th day of June, 1979,
the Board of Aldermen of the Town of Beasley, Fort Bend County,
Texas, passed an Ordinance, the descriptive caption of which is
as follows:

AN ORDINANCE PROHIBITING ANY PERSON UNDER THE

GROUND, PUBLIC SCHOOL BUILDING, PUBLIC SCHOOL
ATHLETIC FIELD OR ARENA, OR ANY PUBLIC PARK OR
ARENA IN THE TOWN OF BEASLEY; PROVIDING FOR A
PENALTY THEREFOR; AND ESTABLISHING AN EFFECTIVE
DATE.

This will therefore give notice by publication of the
passage of said Ordinance as directed by the General Laws of the
State of Texas.
