

ORDINANCE NUMBER 105

AN ORDINANCE OF THE CITY OF BEASLEY, FORT BEND COUNTY, TEXAS, CHANGING FROM A CLASS "B" CITY TO A CLASS "A" CITY AND VERIFICATION THEREOF IN ACCORDANCE WITH LOCAL GOVERNMENT CODE 6.02.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEASLEY, TEXAS:

SECTION 1. Evidence has been presented by reliable and credible authority that as of November 19, 1996 there are 600 or more inhabitants in the City of Beasley, Texas and the City Council acknowledges that number to be true and correct.

SECTION 2. The City Council here in acknowledges that one manufacturing establishment exist within the corporate limits of the City of Beasley, Texas.
