

ORDINANCE NO. 106

AN ORDINANCE FOR THE TOWN OF BEASLEY, TEXAS, PROVIDING FOR THE PLACEMENT OF VARIOUS STOP SIGNS, YIELD SIGNS, ONE WAY TRAFFIC SIGNS, NO PARKING SIGNS, SPEED LIMIT SIGNS, AND OTHER TRAFFIC CONTROL DEVICES AT VARIOUS LOCATIONS THROUGHOUT THE TOWN; DETERMINING AND ESTABLISHING SPEED LIMITS AT VARIOUS LOCATIONS WITHIN THE TOWN; PROVIDING FOR THE MAINTENANCE BY THE TOWN SECRETARY OF A LIST OF SUCH SIGNS; PROVIDING THAT FAILURE TO OBEY SUCH SIGNS IN ACCORDANCE WITH THE UNIFORM ACT REGULATING TRAFFIC ON HIGHWAYS OF THE STATE OF TEXAS, TRANSPORTATION CODE 502.401 WHICH SHALL CONSTITUTE A MISDEMEANOR PUNISHABLE BY A FINE NOT TO EXCEED TWO HUNDRED AND NO/100 DOLLARS (\$200.00); CONTAINING A SEVERABILITY CLAUSE; PROVIDING FOR THE REPEAL OF ANY ORDINANCES, RESOLUTIONS, OR INFORMAL POLICIES OF THE TOWN OF BEASLEY WHICH ARE IN ANY MANNER IN CONFLICT OR INCONSISTENT WITH THIS ORDINANCE; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BEASLEY, TEXAS:

Section One:

The Town Council of the Town of Beasley hereby finds and determines that it is in the best interest and promotes the safety and welfare of the citizens of Beasley that various stop signs, yield signs, one way traffic signs, no parking signs, speed limit signs, and other traffic control devices as defined in the uniform act regulating traffic on highways for the State of Texas, Transportation Code 502.401, be and they are hereby authorized, to be placed and maintained in accordance with the list of such signs attached hereto as Appendix A, Attachment 1, Attachment 2 and incorporated herein for all purposes, which list shall be maintained in the Town Secretary's Office.

Section Two:

Whenever any ordinance of this Town designates and describes a stop sign, yield sign, no parking sign, one way traffic sign, speed limit sign, or other traffic control device, it shall be the duty of the Director of Public Works or those persons acting under his direction and control to place and maintain such traffic control device.

Section Three:

The Town Council may, in its discretion, from time to time designate certain intersections or other locations to be controlled in one or more directions by stop and /or yield signs, or other traffic control devices. In the event of such designation, it shall be the duty of the Director of Public Works to place and maintain the appropriate sign or signs at the designated location or locations. A list of such designations shall be maintained in the Town Secretary's office, consisting of location, and type of sign or signs designated by the Town Council and the purpose or function of such sign.

Section Four:

Any person who violates the prohibition, direction or other meaning of any traffic control device, as that meaning is set forth under the Uniform Traffic Act shall be guilty of a misdemeanor which shall be punishable by a fine of not to exceed Two Hundred and No/100 Dollars (\$200.00).

Section Five:

It is hereby declared to be the intention of the Town Council that the several provisions of this ordinance are severable, and if any court of competent jurisdiction enters a final order which holds that any section, sub-section, sentence, clause, phrase, or other portion of this ordinance is invalid, illegal, or otherwise unenforceable, then any such portion shall be deemed a separate, distinct and independent provision, and any such ruling shall not affect any other provisions of this ordinance which are not specifically designated as being illegal, invalid or unenforceable.

Section Six:

Any and all rules, ordinances, police regulations, resolutions, and/or policies of the Town of Beasley, whether written or otherwise, which are in any manner in conflict with or inconsistent with this ordinance, shall be and are hereby repealed to the extent of such conflict and/or inconsistency.

Section Seven:

This ordinance shall be effective from and after the date of its passage and approval and the publication of its caption as required by law.




