

ORDINANCE NO. 2005-2

AN ORDINANCE AMENDING SECTIONS TWO (2) AND SECTION FOUR (4) AND SECTION EIGHT (8) OF ORDINANCE NO. THIRTY EIGHT (38), PASSED AND APPROVED ON THE 21ST DAY OF JUNE, 1977, BY THE TOWN OF BEASLEY, TEXAS CONCERNING THE REGULATIONS OF SALESPERSONS IN THE TOWN OF BEASLEY, TEXAS; AND ESTABLISHING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF BEASLEY, FORT BEND COUNTY, TEXAS:

I. That section Two, Section Four (4) and Section Eight (8) of Ordinance No. 38, concerning the regulations of Salesperson in the Town of Beasley, as set out above, and as passed and approved heretofore on the 21st day of June, 1977, shall be amended to read as follows:

SECTION 2: That any person desiring to engage in the business of itinerant merchant or that of peddling or soliciting within the corporate limits of the Town of Beasley, Texas, shall make written application for a permit or license to do so to the Secretary of the Town of Beasley, which application shall show the name and address of the applicant, the name and address of person, firm, or corporation which such applicant represents, the kind of goods, ware, and merchandise offered for sale or services, and whether such applicant upon any such order so obtained will demand, accept or receive payment or deposit of money in advance of final delivery, and the period of time such applicant wishes to solicit, sell, or take orders in the Town of Beasley, such written application shall be a fee of Five and No/100 (\$5.00) Dollar and no permit hereunder shall be issued, until such fee has been paid by applicant and such written application has so filed with the Secretary of the Town of Beasley for a period of twenty-four hours.

SECTION 4: For Itinerant Merchants offering for sale bankrupt stock, fire or water damaged stock, or goods, wares, merchandise. For making negatives, exposing plates or films or making photographs or pictures, for magazine or newspaper subscriptions, for peddling, using motor vehicle, for foot peddling, for Insurance Salesmen, and for Insect or Rodent Control Service Salesmen - \$25.00 for 30 consecutive days and can be renewed every 30 days for a period of 90 days. Then an application fee of \$5.00 and request in writing must be re-submitted.

SECTION 8. That any person violating any provision of this ordinance shall upon conviction be fined in any sum not less than Ten (\$10.00) Dollars, nor more than Five Hundred \$500.00) Dollars; and each and every day a person shall peddle without a license shall be a separate offense.
