MINUTES REGULAR CITY COUNCIL MEETING TUESDAY – APRIL 16, 2019 – 6:30 P.M. BEASLEY CITY HALL 319 SOUTH 3RD ST., BEASLEY, TX 77417

Call to Order: Mayor Kenneth Reid called the meeting to order at 6:30 p.m.

Roll Call: Council Members Dale Lindemann, Jerri Lindemann, Al Becan, and Douglas Harris were present. Yvonne Meyer was absent.

Approve minutes from March 19, 2019 meeting: Mr. Lindemann made the motion to approve the minutes as written and Mr. Harris seconded. *Motion carried*.

Mayor Announcements: CenterPoint franchise agreement with City of Beasley will be adjusted to \$2,092.10 monthly beginning July 1st. Currently the payment is \$2,072.11.

The District Attorney's Office has sentenced Ty Tulle to 165 days in jail.

Patsy Schultz is retiring from the Tax Office effective April 30, 2019 after serving more than thirty (30) years, fifteen (15) as tax assessor/collector. An interim tax assessor/collector will be appointed until one can be elected in the November, 2020 election.

Communication from the public

Each speaker is limited to three (3) minutes. In accordance with the Texas Open Meetings Act, the City Council may not discuss or take action on any items not posted on the agenda.

No general public attended.

OLD BUSINESS

A. Discuss and consider calling a public hearing on the adoption of a comprehensive plan for long-range development of the City, including provisions on land use, transportation and public facilities.

preserve places and areas of historical, cultural and architectural importance and significance; to lessen congestion in the streets; to secure safety from fire, panic, and other dangers; to provide adequate light and air; to prevent the overcrowding of land to avoid undue concentration of population; to facilitate the adequate provision of transportation, water, sewerage, schools, parks and other public requirements.

E. Discuss and act on Public Utility Commission's 2019.

The 2018 CPI preferred rates are as follows:

The City's default rates for 2019 are as follows and are higher than 2018 rates.

Residential: \$0.28, Non-Residential: \$0.73, Point-to-Point: \$2.07

Mr. Lindemann made the motion to accept the 2019 default rates for 2019 and Mr. Harris seconded. **Motion carried**.

Financial Report: Ms. Wanda Andel presented Council with a Financial Statement showing the General Fund with \$206,456.31 and the Water/Sewer Account with \$125,740.48. Mr. Harris made the motion to accept the report, pay the bills and Mrs. Lindemann seconded. **Motion carried**.
