Call to Order: Mayor Kenneth Reid called the meeting to order at 6:30 p.m.

Roll Call: Council Members Carolyn Sabrsula, Yvonne Meyer, and Douglas Harris were present. Al Becan was absent due to work.

Approve minutes from meeting March 17th, 2020: Mrs. Sabrsula made the motion to accept the minutes as written and Mr. Harris seconded. *Motion Carried.*

Mayor Announcements: Working on removing some Honey Bees from 7014 Avenue G. This has been an on-going situation for many years, and we are now getting complaints from neighbors about being stung. Helping Hands has been contacted and are willing to assist depending on the amount of damage. Misty has also contacted a few exterminators for the removal as well.

We have been working on getting some Sanitizing supplies for lower income families; however Fort Bend only issued enough for us to have here at City Hall. Misty is still working on trying to get us some Hand Sanitizer as well.

Financial Report: Ms. Meyer made the motion to accept the Financial Report as written, Ms. Sabrsula seconded the motion. *Motion Carried.*


City Building Report: No Building Permits to report
