**Call to Order:** Mayor Kenneth Reid called the meeting to order at 6:30 p.m.

**Approve minutes from meeting:** Yvonne Meyer made the motion to approve the minutes from the meeting held on January 26, 2021. Doug Harris seconded the motion. *Motion carried.*

- Discussion and possible action accepting Ordinance 2021-03; an Ordinance cancelling the May 1<sup>st</sup> General Election and declaring each unopposed candidate elected to office; and no "Write In" candidates have filed by filling deadline of 5:00 p.m. on February 19<sup>th</sup>, 2021; providing a severability clause and providing an effective date.

- Bonnie Meyer made the motion to cancel the May 1<sup>st</sup> General Election. Doug Harris seconded. *Motion carried.*
- Discussion and possible action to adopt or deny the local exemptions for Fort Bend County CAD for the tax year 2021 which includes the following:
  - ❖ Residential Homestead Exemption – No Exemption
  - ❖ Over 65 Exemption -\$3,000.00
  - ❖ Disability Exemption - \$3,000.00

**Financial Report:** Doug Harris made the motion to approve the presented Financial report for the Month of January. Carolyn Sabrsula seconded the motion. *Motion carried.*
